# **Urgent Action Network Guide**

The Urgent Action Network (UAN) is Amnesty International's Global Rapid Response System responding to individuals and communities who are under immediate threat of human rights violations. When Amnesty International (AI) issues an Urgent Action on behalf of an individual or community, we mobilize activists across the world to take action in a short amount of time to bring about change for individuals and groups whose human rights are at immediate risk.

# **Important Terms to Know:**

# **INDIVIDUALS AT RISK**

Refers to an individual, a group, or a community who have been subjected to, or are at risk of, a human rights violation(s).

# **HUMAN RIGHTS DEFENDER**

Refers to an individual or group of people, who act to promote and protect human rights through peaceful means.


# PRISONER OF CONSCIENCE

A person who is wrongfully detained solely because of who they are or their political, religious, or other conscientiously held beliefs, and who has not advocated hatred or violence, or used violence in the circumstances leading to their imprisonment.

# ETHICAL CAMPAIGNING

Working with and for Individuals at Risk (IAR) is the foundation stone of Amnesty International (AI) and our single most important ethical principle and policy is based on mutual respect and dignity when conducting work with individuals affected by human rights violations and abuses. AI prioritizes *Informed Consent* to ensure that nothing that Amnesty does or says is against the wishes of the Individual at Risk involved and does not put them at greater risk of harm ("Do No Harm" principle).

# How The Urgent Action Network Works



## **HUMAN RIGHTS ARE VIOLATED**

Human rights violation(s) occurs against an individual or community somewhere in the world.



### AMNESTY INTERNATIONAL INVESTIGATES

Amnesty International is alerted by the individual(s), family members, or lawyers. Research and investigation immediately begins on the case.



### AMNESTY ISSUES AN URGENT ACTION

Background on the case is shared and guided messaging calling on government authorities to uphold and protect human rights, and to stop and remedy the human rights violation(s) that have occurred.



# URGENT ACTION NETWORK MEMBERS MOBILIZE ACTION

By writing emails, letters, signing petitions, hosting events, and engaging through social media to bring attention to the injustice(s).



## **RESULTS**

The collective actions often lead to justice for individual(s) at risk because authorities become aware that the world is watching them.



# **Case Study: Munther Amira**

# **Palestinian Human Rights Defender**

<u>Munther Amira</u>, Palestinian human rights defender and social worker, was arbitrarily detained by Israeli forces on December 18, 2023. On January 11, 2024, an Israeli military court confirmed a four-month administrative detention order against him.



Amnesty International (AI) was alerted of Munther Amira's case and gathered the details of his situation, including consent to campaign for his release.

Al researched the appopriate targets for Munther Amira's case which was Major General Yehuda Fox, Central Command of the West Bank for the Israeli Defense Forces.





An appeal for his release was issued through the Urgent Action Network and tens of thousands of members from across the globe took action through letter writing, email, petitions, social media, hosting public and awareness events, which eventually led to Munther Amira's release!



# ANATOMY OF AN URGENT ACTION

Below are some tips to help navigate an Urgent Action

**Tip:** Each Urgent Action (UA) has a unique numeric code. The first number denotes the sequence by which Amnesty launched the UA for the given calendar year, and the second number denotes the calendar year.

**Tip:** Reporting helps us to measure impact and we share the total numbers of actions taken with the officials we are trying to persuade and the individuals we are trying to help!

International mailing addresses are verified by Amnesty USA to ensure USPS delivery to each country is possible.

**Tip:** When available, social media handles of targets will be provided.

**Tip:** Please exercise politeness in all your appeals!

# **URGENT ACTION**

NAME AND PRONOUN: Name of individual(s) or community at risk.

LINK TO PREVIOUS UA: This section will provide the link to previous UAs on the case if applicable. If UA is extended or updated, the updated versions will be denoted as First UA, Second UA...

Tip: When possible we will also provide a domestic address to send your appeal!

Tip: This date reflects the timeframe for requested action. UA's are often extended depending on the current status or outcome.



# FIVE WAYS TO RAISE PUBLIC AWARENESS ON AN URGENT ACTION



Building awareness and and mobilizing action on the individuals and communities we work with and for is an important part to Amnesty's advocacy work. Hosting public actions in your community will help raise the profile of the individual or community at risk, and will help spotlight perpetrators of human rights violations so we can hold them accountable to their actions.

Submit an article to your local or school paper that tells the story of the indvidual or community at risk and the human rights violations they are facing. Guide people on how to take action.



Create a short information video (90 seconds or less) on the Urgent Action and share via social media, inviting people to take action.



Create a visual such as a mural or flyer that provides information on the individual or community at risk and post in visible spots. Include ways for people to take action.



Organize a public event such as a demonstration, vigil, teachin, letter-writing, or phone banking event (taregtting the local Embassy in the U.S.) for the individual or community at risk.
